Cut away deadwood!

Support your claims!

Don't be a weasel!

Avoid ambiguous and vague formulations!

# Review: writing (not) good

Avoid redundancies	"RAM memory" "objectives that programmers intend to achieve"	"RAM" "objectives of programmers"
Prefer simple words	"utilise" "a plethora of" "a number of"	"use" "many different" "several" or "many"
Use strong verbs	"provides a rationale for" "makes available"	"justifies" or "explains" "provides" or "offers"
Drop empty qualifiers	"very related to our work" "remained broadly unexplored"	"related to our work" "remained unexplored"
No slang & colloquialisms	"I bagged my M.Sc. degree"	"I acquired an M.Sc."
No over-blown claims	"our work has amassed impact and community-wide adoption"	(three known uses; two in own projects)
Use active voice	"two cases were considered in our evaluation"	"we evaluated two cases"

### Tense changes meaning

#### Note the difference:

"Our implementation needed less memory than other systems."

→ we observed this (in our experiments)

"Our implementation needs less memory than other systems."

→ this is a general truth

### Parallel clauses

Parallel clauses, which follow the same structure, are used in all lists.

**Example:** The following sentence is badly violating this principle: "Approaches for improving performance include the use of faster CPUs, optimising existing algorithms, and to approximate solutions." Better versions:

- "... include the use of faster CPUs, the optimisation of existing algorithms, and the approximation of solutions."
- "... include using faster CPUs, optimising existing algorithms, and approximating solutions."
- "... are to use faster CPUs, to optimise existing algorithms, and to approximate solutions."

Lists and enumerations (whether inline or not) should always use parallel clauses.

(In contrast, sequences of parallel sentences in paragraphs are usually tiring.)

# Format and Layout

### Format and layout

#### There are several main aspects to formatting and layout:

- Space
- Fonts
- Colour
- Arrangement

#### General guidelines:

- Be consistent
- The goal is readability and clarity, not originality or attention grabbing
- Mind the medium (paper size? colour printing? etc.)

### Space

- Margin sizes
- Spaces before and after various parts (headings, tables, figures, lines, etc.)
- Indentation (=shifting start of lines away from left margin) of paragraphs, lists, enumerations, etc.

#### **Guidelines:**

- Follow spacing instructions where available
- Be generous (empty space is the most precious resource in layout)
- Follow conventions

**Example:** In English writing, there is usually no additional vertical space between paragraphs, but their first line is indented. In German, it is the opposite.

make it stand out or appear stronger. The same is true for **text** written in bold or *italics*. Even huge font sizes do **not** really have much effect. ALL-CAPS ARE EVEN WORSE, SINCE THEY IMPAIR READABILITY. The same *applies* to using different *FONTS*. The strongest form of emphasis is

Writing something in very large font does not necessarily

empty space

since it is the ONLY EMPHASIS that does not distract from the content but instead makes the reader **focus** on it. Space guides and *clarifies structure*. This effect is widely used in layout, in printed and online media alike. Logos often include much **white space** or require **wide margins** for this reason. Note that emphasising too much achieves the opposite effect.

#### **Fonts**

- Family (Times, Comic Sans, etc.)
- Shape and highlight (normal, italic, bold, ...)
- Size

#### **Guidelines:**

- Use a single main body font for most text (preferably serif, e.g., Times)
- Maybe use one or two other fonts for special cases (headlines, code, ...)
- Math uses fonts for distinguishing identifiers respect these conventions
- Use few sizes, defined by text structure (headlines, body text, footnotes, ...)

### Inline emphasis

#### Emphasis of words in text has several purposes:

- Main use: to highlight new technical terms when first defined
- Less common: when writing about a word rather than about its meaning

**Example:** A few years ago, examples of neologisms still included *neologism*.

- Rarely: to set apart foreign language phrases
- Never: to emphasise an important message

#### How to emphasise:

- set words in italics or boldface
- italics leads to calmer overall look (often preferred)
- boldface stands out on page level (sometimes useful, e.g., for textbooks)
- underlining is never used in print (exception: some artistically styled books)

### Colour

Colour is rarely used much, since many research publications (also) appear as black-and-white prints

#### **Guidelines:**

- Colour is very powerful use with care
- You may use colour even if a report is also printed in black and white, since the digital version can still benefit from it, but do not rely on it in this case
- Avoid colours that are not readable or plain ugly

### Arrangement

- Number of text columns
- Placement of figures and tables
- Use of special layouts (e.g., text flowing around a figure)

#### **Guidelines:**

- This is usually partly determined by applicable formatting guidelines
- LaTeX has good default solutions for arranging content
- · Use special layouts sparingly

# **Punctuation**

#### Punctuation

#### Punctuation is the use of punctuation symbols, most commonly:

- Full stop .
- Comma,
- Semicolon;
- Colon:
- Hyphen -, en-dash –, and em-dash —
- Apostrophe ', quotes " ", and single quotes ' '
- Parentheses ()

Rules apply, but often depend on context (medium, style guide, preference).

### Full stops and semicolons

#### **Full stops**

- end sentences that do not already have a . in the end for other reasons
- follow after abbreviations (incompl. words, not acronyms)

Note: only use standard abbreviations (e.g., etc. or Fig.)

Note: sentences should never start with abbreviations

are not used in titles and headings

#### **Semicolons**

- separate sentences like full stops, if a closer link is desired (but are not require a capital letter to follow)
- can be used instead of commas in list (useful if list items contain commas)
- should be used, but not too much

#### **Examples:**

Semicolons connect phrases that could each be sentences; that's their main use. Figure 2 uses the same format as Fig. 1.

A similar conjecture was made by Smith et al.

### Colons

#### Colons strongly connect parts of text

Can express as follows or for the following reason

**Example:** There are two essential resources: time and memory.

**Example:** The system was excluded from our evaluation: it ran out of memory in all experiments.

- Is mostly used inside a sentence (even if followed by what could be a sentence)
  - $\rightarrow$  words after : are usually lower case
- Can also be used in a clause that initiates several sentences or a quote
  - → in these (less common) situations, words after: start upper case

**Example:** As Abraham Lincoln once put it: "The problem with quotes found on the Internet is that they are often not true."

### Hyphens

#### Hyphens are used to connect words to form a whole

- Connect words split across two lines (usually done by software, but needs review)
- Build words from parts

```
Examples: "hash-based", "near-memory computing", "co-operate" (British)
```

Overwrite right associativity of longer noun phrases

**Example:** "American history teacher" vs. "American-history teacher"

### Note that hyphenation depends on context and intended meaning

**Example:** Up until to date, state-of-the-art software is defined to be up-to-date with the state of the art.

**Example:** The headmaster recovered from his embarrassment almost as quickly as he had re-covered his backside.

### Dashes

Dashes are used to separate parenthetical remarks from the rest of the sentence

#### **Examples:**

- Many uses of dashes including this one could also use commas instead.
- If a sentence uses a comma as in this example –, then the dash does not replace it.
- There is no closing dash at the end of a sentence as in this example.

#### Dashes can be written in two ways:

- The shorter en-dash with spaces is more common in British spelling and also in other European languages.
- The longer em-dash without spaces is common in American spelling—and is also preferred by some other style guides.

Never use em-dashes with spaces (empty gap visually too large).

Whichever variant you pick, be consistent.

#### Commas

#### Commas have many uses in English (non-exhaustive list)

- Items in a list or enumeration: "I like apples, mangos, and strawberries"
- Coordinated (equal-rank) adjectives: "the sweet, fragrant, mouth-watering scent of mangos"
   But only if they could swap places, e.g., no comma in "fast stochastic gradient descent" or "useless optimal solution"
- Introductory phrases of sentences:
  - "However, air-shipped mangos are bad for the environment."
  - "Considering the carbon footprint of his purchase, he bought fresh strawberries instead."

Some such commas are optional: "In Section 4(,) we evaluate our approach."

- · Parenthetical remarks and clarifying insertions:
  - "The fastest algorithm, Quicksort, ran in under 45 seconds."
  - "The fastest algorithm, which we therefore chose for our software, was Quicksort.
  - "The fastest algorithm, as determined by averaging ten runs, was Quicksort."

This comma can sometimes be optional: "And is was memory-efficient(,) too."

- Independent clauses joined by conjunctions
  - "We met only twice, but/and/so/... we did not have dinner together."

But not for compound verbs/nouns (i.e., lists of two): "We met twice and had dinner." and "We had dinner that night and breakfast next morning."

Out-of-order dates: "May 21, 2019" (but: "21 May 2019")

### That and which

English distinguishes defining and non-defining relative clauses.

#### That and which

English distinguishes defining and non-defining relative clauses.

#### **Defining:** (restrictive)

"We recommend the hash-based algorithm that was the fastest in all experiments."

- Implies that several hash-based algorithms were considered
- The specific algorithm that is recommended is defined by being the fastest
- → deleting the relative clause would cause ambiguity

### Non-Defining: (non-restrictive)

"We recommend the hash-based algorithm, which was the fastest in all experiments."

- Several algorithms have been considered, but only one was "the hash-based"
- This one happened to be the fastest
- → deleting the relative clause would not cause ambiguity

Know the differences: no comma vs. comma; that can only be used in defining clauses (which, who, where, why, whose, and whom can be used in either case)

### E.g., i.e., and such as

#### Such as: use of commas based on defining vs. non-defining

- "Sorting algorithms, such as Quicksort and Bubblesort, are taught to undergraduates."
- "Algorithms such as Quicksort and Bubblesort are well-suited for teaching basic data structures."

#### e.g. and i.e.

- These abbreviations mean for example and that is (in other words), respectively
- They always start a parenthetical remark and must be preceded by a comma
- They may or may not be followed by a comma (your choice; be consistent)
- Another comma is needed to close the parenthesis (if not at end of sentence)
- Like all abbreviations, they should never start a sentence

**Example:** Sorting algorithms, e.g., Quicksort and Bubblesort, are good for teaching basic algorithmic concepts.

#### The serial comma

The final conjunction in a list may or may not be preceded by a comma.

#### The serial comma (a.k.a. Oxford comma):

- should be used (or omitted) consistently
- adds clarity

Example: "I thank my parents, Madonna, and the Pope."

- appears slightly more formal
- is unrelated to the use of commas before and as a conjunction of independent clauses (where we could also use conjunctions like but or a full stop)

Example: "We verified our algorithm, and we also ran experiments."

• is not used with two-item lists, esp. for correlative conjunctions (that come in pairs)

**Example:** "Existing solutions are either fast or memory-efficient."

# Apostrophes and quotation marks

### Apostrophes are used in contractions, such as "can't"

- avoided in formal writing, but can be used in textbooks and informal reports
- most research report style guides discourage them, but some enforce them

### Apostrophes also indicate possessives, as in "Tarjan's algorithm"

- Followed by **s** for singular nouns: "the algorithm's complexity"
- No **s** for plurals: "the users' comments"
- Optional s for singular words that end in s: "Markus' lecture" or "Markus's lecture"
- Never for possessive forms of pronouns: "its main reason" or "it was hers"

The **Greengrocers' Apostrophe** is the erroneous use of apostrophes, especially in plural forms ending with s ("Fresh apple's!").

### Quotation marks

Quotation marks are used for quotations and to mark literal uses of text

- Most styles prefer double quotation "..." (shape in English: 66 ... 99), but one can also consistently use single quotes '...'
- The other style of quotes is used when nesting quoted strings inside quotes
- Different from straight quote " found on keyboards
- Many style guides move closing "after commas or full stops that follow immediately

**Example:** "WWW," which is short for "World Wide Web," is one of the few abbreviations that take longer to speak than what they abbreviate.

The reason is aesthetics, but especially computer scientists often avoid this style to prevent (possibly disastrous) confusion when quoting source code, where punctuation often is significant

**Example:** Delete the temporary files using the command "rm -rf ./tmp".

#### **Parentheses**

#### Quotation marks are used for parenthetical remarks

· Useful for brief insertions, especially in technical writing

**Example:** Figure 1 compares Quicksort (left) with Bubblesort (right).

**Example:** Artificial intelligence (AI) uses a variety of methods, such as Machine Learning (ML) and Knowledge Representation and Reasoning (KRR).

 Should be avoided for longer phrases or sentences: use commas, dashes, or footnotes; or simply unravel your writing

# Capitalisation

#### English uses upper case letters only rarely:

- sentence beginnings
- proper names (including identifiers such as "Theorem 3" or "Yannakakis Algorithm")
- most multi-letter abbreviations (depending on convention)
- titles and headings
  - Style 1: only capitalise start and words after ":"
  - Style 2: capitalise all words other than short common words such as "for", "on", or "and"

#### Some names are stylised to use unusual or distracting case

- Decide what is acceptable: readability weighs heavier than other people's extravagance (esp. lower case at sentence starts is irritating and puts style over content)
- Ignore any other special styles (colour, font, etc.) of names in regular text

### Whitespace

#### Spaces are used between words, but also

• to separate parentheses from words on their outside

```
Example: "... shown by Smith[42]." is wrong; "... shown by Smith [42]." would be correct.
```

- around (parenthetical) en-dashes
- after sentences (double spaces were used after full stops until the mid-20th century; this is mostly obsolete now)

Note: In English, there are no spaces before sentence marks or within long numbers
